

## BYYO – Terms and Conditions – Camp BYYO 2026

### 1. Payment

A deposit payment of £350 is due within 48 hours of sign up in order to confirm your place. If more time to pay the deposit is needed, please make the request by emailing [office@bbyo.org.uk](mailto:office@bbyo.org.uk). Any such extension will be at the sole discretion of BYYO UK.

To be eligible for the early-bird pricing, your fully completed application must be received by us by 12:00 noon on Friday 6<sup>th</sup> February, 2026.

The remaining balance for Camp BYYO is due on 1<sup>st</sup> April 2026 (or on sign-up if you apply after this date). Please check the brochure on our website for the up-to-date price of camp.

All payments should be made via bank transfer to the bank account below, indicating the name of the participant with the payment.

All financial assistance applications are treated in the strictest confidence, and all such decisions are made solely on the basis of need by an independent bursary committee. ### 2. Cancellations & Refunds

If, having signed up for Camp BYYO, a participant wishes to cancel their place any time before the start of Camp BYYO for any reason, notice of cancellation must be given as soon as possible by email addressed to [office@bbyo.org.uk](mailto:office@bbyo.org.uk).

If notice of cancellation is received by BYYO UK before 1<sup>st</sup> April 2026, £200 of the deposit will be refunded. If notice of cancellation is received on or after 1<sup>st</sup> April 2026, all payments are non-refundable, unless alternative arrangements have been agreed with BYYO UK. Additionally, if notice of cancellation is received on or after 1<sup>st</sup> April 2026, BYYO UK reserves the right to invoice the participant or their parents / guardians for any payments that should have been made by the date of cancellation but have not been made.

No refunds will be offered after Camp BYYO has started.

Should any participant leave Camp BYYO before the end of camp for any reason, BYYO UK will contact their parents/guardians or alternative contact person who will be liable to collect them from the campsite within 24 hours of such contact. No refund will be given and any costs incurred will not be refunded. Where arrangements cannot be made or are not made for the participant by their parents/guardians or alternative contact person within that 24 hour period, BYYO UK reserves the right to make suitable travel arrangements and the costs of such arrangements shall be paid by the participant and/or parent/guardian/alternative contact within 7 days of the issue of an invoice setting out the costs incurred.

Any participant who has been awarded a bursary contribution towards the cost of the programme by BYYO

UK and leaves before the end of Camp BBYO for any reason may be required to repay some or all of the amount of the bursary awarded to them. Such requirement will be notified to the participant or their parents / guardians, and such repayment should be made within 28 days of the date of such notification.

BBYO UK reserves the right to cancel, amend or curtail any activity associated with Camp BBYO as a result of any situation beyond its reasonable control, such as extreme weather, industrial action, withdrawal of services by a supplier or infectious disease. In such circumstances, BBYO UK reserves the right not to make any refund of monies paid and accepts no liability in respect of any such situation.

BBYO UK recommends that all participants and leaders obtain suitable travel insurance which should cover cancellation, curtailment, medical and other potential issues.

### **3. Travel Arrangements**

Travel to and from Camp BBYO is provided by BBYO UK at no extra cost. Travel from Greater London will be via coach, however the travel methods from other locations will depend on demand.

Any requests for participants to travel outside of the group arrangements or not be met when returning from Camp BBYO must be made by email to [office@bbyo.org.uk](mailto:office@bbyo.org.uk) at least 48 hours before the date of that travel (other than in case of absolute unavoidable emergency) and any such requests (whenever received) are not to be treated as agreed until actually agreed by BBYO UK. In the absence of such agreement by BBYO UK participants will be required to travel with the group and not allowed to leave. This is for the safety and wellbeing of all participants.

### **4. Leaving our camps / Visitors to our camps & events**

Participants are not allowed to leave our residential sites or separate from the main group without express permission from a BBYO UK member of staff. If permission is granted, participants will only be able to leave accompanied by a leader.

Visitors (whether friends or family or otherwise) are not allowed to visit our camp or any event without express permission from a BBYO UK member of staff.

### **5. Compliance with Code of Conduct**

Participants and leaders are required to comply with the [BBYO UK Code of Conduct](#). The BBYO UK Code of Conduct sets out the disciplinary process in case of breaches of that code. Participants should be aware that serious breaches of the Code of Conduct might result in the participant being removed from activities and / or sent home from Camp BBYO (in which case the provisions of Clause 2 in relation to no refunds and additional costs) will apply.

If any breach of the BBYO UK Code of Conduct by a participant results in any damage or loss to property or premises, the parents / guardians of that participant will be held responsible for the full costs of any such damage or loss and any consequential loss arising as a result of that damage or loss.

BBYO UK may update or revise the Code of Conduct at any time.

Participants and their parents / guardians are required to read and sign their acceptance of BBYO UK's Code of Conduct as part of the sign-up process.

### **6. Searching**

If there is a reasonable suspicion that any participant is in possession of unauthorised medication, drugs, alcohol, tobacco, weapons, bladed items or has access to physical or online / electronic material that is inappropriate, BBYO UK reserves the right to search that individual's personal possessions or bed / sleeping area during the programme. If prevented from carrying out any such search, BBYO UK is entitled to take this as an indication that such prohibited items may be in the possession or under the control of such participant or leader.

## **7. Medical**

Participants and their parents / guardians are required to complete the BBYO UK Medical Form promptly when requested and to disclose all relevant conditions and information and to update any such information prior to the programme.

Any failure to disclose medical information requested on the BBYO UK Medical Form or the disclosure of inaccurate or misleading medical information will be grounds for rejection or dismissal from Camp BBYO and in this situation, there shall be no refunds of any amounts paid.

BBYO UK is committed to inclusion and will seek to make reasonable and proportionate adjustments in order to allow applicants to join Camp BBYO. In the unlikely event that BBYO UK considers that it is unable safely or reasonably to meet the medical needs of an applicant as set out in the completed BBYO UK Medical Form, BBYO UK will promptly respond to the relevant parents / guardians setting out its concerns. Ultimately, BBYO UK has the absolute right to refuse an applicant whose medical needs it reasonably considers it is unable reasonably and safely to accommodate.

Where BBYO UK consider it necessary, based on the information disclosed by a participant on their BBYO UK Medical Form, BBYO UK will write a care plan for that participant. Any such care plans will be shared with the participant's parents / guardians prior to the start of Camp BBYO.

In the event of any medical emergency of any kind, dental or medical treatment, as advised to be necessary by the appropriate medical authority, may be given to the participant. In the case of medical emergency, such treatment may be given without first contacting the participant's parents / guardians if medically necessary.

Any medication brought to Camp BBYO by participants (whether prescription medication or not) must be handed over to the leaders, (other than EpiPens and inhalers where the care plan specifies that such medication should be retained by the participant). BBYO UK will do its best to store such medication in accordance with any instructions given but can not guarantee its safety or security and is not liable for any loss or damage to that medication (other than in accordance with the operation of law).

The participant agrees to receive and take their medication as detailed in the BBYO UK Medical Form and otherwise to abide by any requirements contained in their care plan.

BBYO UK reserves the right to send home any participant because of any medical / emotional / psychological / developmental condition (whether or not diagnosed or disclosed) that cannot be reasonably managed at Camp BBYO (with regard to any reasonable factors including but not limited to cost, efficacy, professional recommendations, timing, logistical ease, or impact on other participants, leaders, or BBYO UK staff).

## **8. Amendments to Terms and Conditions**

BBYO UK reserves the right to amend, alter, substitute or in any other way vary these terms and conditions and the participant is deemed to accept the terms and conditions so adjusted from time to time.
